**Equality** means treating everyone fairly. It means making sure everyone gets the help they need to have the same chances to do what they can.


## What does the law say?

#### **PREGNANT**



## How do people discriminate?

The **Equality Act 2010** says that there are lots of ways that these groups can be discriminated against. The act protects them from this.



**Discrimination** means treating you worse than other people because you have one of the characteristics.

**Direct Discrimination** is when an organisation or service treats you worse than other people.

Discrimination by Association is when a

service or organisation treats you worse than other people

because you know someone who has one or a more of the protected characteristics.

#### Discrimination by perception

is when a service or organisation treats you unfairly because they think they you have a characterstic even they do not know.

## How do people discriminate?

Indirect discrimination is when a service or organisation does something or has a rule that means you will not be treated fairly because you have a characteristic.

**Discrimination arising from a Disability** is when you are treated unfairly because you have a disability.




**Harassment** means picking on someone or upsetting them on purpose. It is being **bullied** because you have one of the characteristics.



**Victimisation** is when you are treated unfairly because you spoke up or complained about something that has happened.

## What Notts County will do

The club will make sure all our staff know how important it is to treat everyone fairly and not to discriminate.



The club will challenge any discrimination, harassment or victimisation.



We will make as many **reasonable adjustments** as we can to make sure all the club is accessible to all supporters.



**Reasonable adjustments** are changes we make to give a person who is disabled the same chance as anyone else to come to Notts County Football Club.

## What Notts County will do

We will work with supporter's groups and community groups to stop discrimination and harassment.



If you are not happy you can complain to the club about how you have been treated.
